I understand that the scheduling is subject to changes and that classes may be cancelled due to statutory holidays and special circumstances.

During the initial period of my contract, in the case that I am unable to attend classes at **Budokai Judo Club**, I understand that if I miss a minimum of one month, I may receive credit for the time that I am gone by either submitting a written notice 7 days in advance, via registered or certified mail, return receipt requested, notifying a representative of **Budokai Judo Club** for the reason I (or my child) will be absent and the dates of departure and return, or I may hand deliver my notice and get a signed statement from an official of the Club, acknowledging the receipt of my notice, in order to prove that I did send notice.

\_\_\_\_\_ *Member/Parent Initial*

**I (the buyer) may cancel my contract by paying one third of the remaining balance, and giving 30 days written notice of my intent to cancel; however, any fees already collected are non-refundable.** If my account goes more than 90 days delinquent, I may be sent to collections for the full outstanding amount, and if my account becomes delinquent and goes to collections, I will be responsible for any collection fees that may arise due to my failure to pay on time. I can request credit, but I may NOT terminate this agreement due to any temporary injuries sustained before, after, and/or during my training at **Budokai Judo Club**. For time missed due to injuries, see section regarding credit request. **For suspension of membership due to a permanent move, more than 50 kilometres away from the Club, I (the buyer) may cancel my contract by paying a \$1.00 suspension fee, and giving 30 days written notice of my intent to cancel, with legitimate verification of the move; however, any fees already collected are non-refundable.** *If I decide to cancel my membership, it is required that I (the buyer) send my cancellation notice by registered or certified mail, return receipt requested, or hand deliver my notice and get a signed statement from an official at the Club, acknowledging the receipt of my notice, in order to prove that I did send notice.*

## BUDOKAI JUDO CLUB: Dojo Rules and Etiquette

I hereby pledge to follow and abide by the following Budokai Judo Club Dojo Rules and Etiquette:

- Be punctual at all scheduled classes and meetings
- Help keep the dojo clean and in good repair
- Take off outdoor shoes before entering the cub and wear only socks or slippers in dojo
- Wear traditional judo gi properly for all practice sessions
- Women and girls, please wear a white t-shirt under the judo gi
- Keep your judogi clean and in good repair
- Keep your body clean, fingernails and toenails trimmed
- Remove all jewelry and hard objects when practicing
- No Chewing gum, or foods in the dojo
- Remain quiet and attentive while not practicing
- Be courteous and helpful to all fellow judoka at all times
- Use the correct forms of standing and kneeling bows
- Sit in an acceptable position while on the mat (cross-legged or seiza)
- Listen to the instructions from your instructors and address them in an appropriate manner
- Accept instruction from an authorized instructor only
- Practice only techniques appropriate to your age, aptitude and ability and that of your partners
- Seek to practice with higher-ranking partners
- Engage in competition only when authorized by the instructor
- Follow the rules at all times
- Respect the referee's decisions at all times
- Obey the dojo rules relating to first-aid treatments of injuries
- Parents – please do not coach, speak to and/or interfere with students while the class is in session
